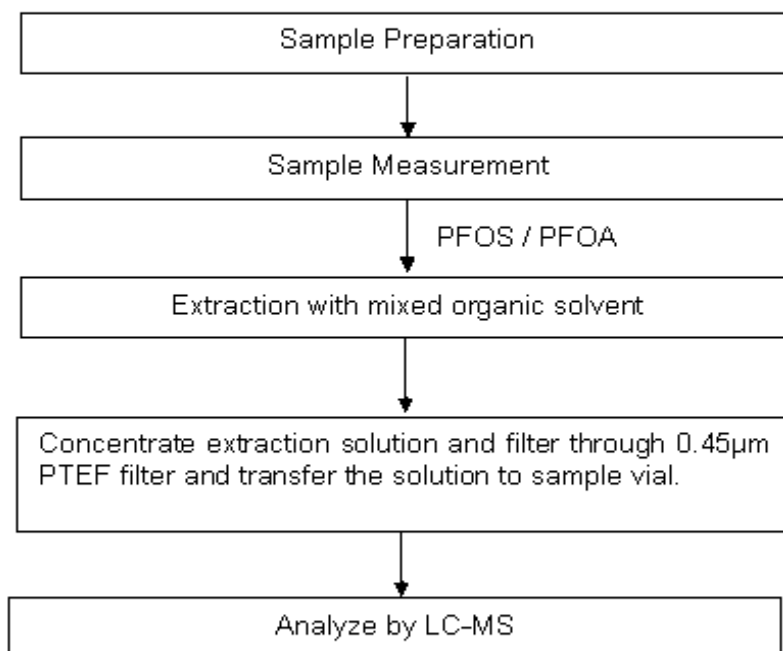

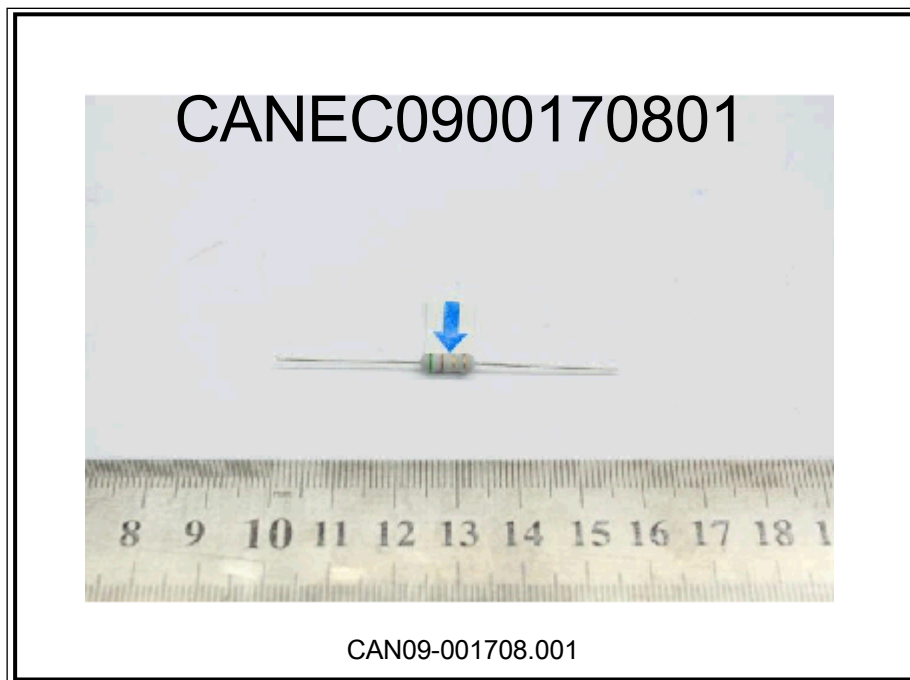
Testing Flow Chart
